I AGREE in consideration for my participation in this 2021 APPLEATCHEE DRESSAGE SHOWS (hereinafter called "Competition") **to the following:** I AGREE that I choose to participate voluntarily in the Competition with my horse as a rider, driver, handler, lessee, owner, agent, coach, trainer, or as a parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent risks of accident, loss and serious bodily Injury including, but not limited to, broken bones, head injuries, trauma, pain suffering or death ("Harm"). I AGREE to release Washington State Horsemen and Appleatchee Riders, Inc. I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of Washington State Horsemen and the Competition. I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) Washington State Horsemen and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition.

I have read the Washington State Horsemen Rules about protective equipment, and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that Washington State Horsemen strongly encourages me to do so while warning that protective equipment cannot guard against all injuries. If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf. ## ABOUT THE ENTRY FORMS



It is the Exhibitor's responsibility to accurately complete the Entry Form. Incorrect and incomplete entries may be charged a Secretary fee and Late Entry fee. See box below.

**Please read the following carefully.**

**ALL SIGNATURES MUST BE IN INK AND BE ORIGINAL SIGNATURES!**

**MAKE COPIES of the entry form for each additional horse.**

Please print or type your entry. Misspellings may result in scores not being credited correctly. Be sure to specify test if a test of choice is entered.

**OWNER/AGENT (trainer)** is defined as any adult who has responsibility for the care, training, custody or performance of a horse at the show and must be on the grounds during show hours. **A Rider may be OWNER/AGENT.** This information **must be provided.**

**AGE OF YOUNG RIDER:** Individuals are eligible as Young Riders from the beginning of the calendar year in which they reach the age of 16 until the end of the calendar year in which they reach the age of 21.

**AMATEUR HIGH SCORE:** To be eligible for USEF or WSH Amateur High points, a USEF or WSH amateur card is required. A WSH Amateur application can be filed with the Show Secretary, but must be done at least 1 hour prior to the class. The WSH Amateur fee is \$12 for members, \$15 for non-members. This is waived for Members participating in (2) WSH Annual High Score Awards Competitions. (www.washingtonstatehorsemen.org) **CARDS MUST BE PRESENTED FOR INSPECTION UNLESS A PHOTOCOPY IS INCLUDED WITH ENTRY.**

If any one of the following is missing, **your entry will be held at the office** and an additional secretary fee plus a late entry fee of \$20.00 may be charged.

**A: Signatures in TWO PLACES, plus parent or guardian if rider is a minor.**

**B: All fees must be paid in FULL.**
